MSEDCL supplies electricity to staggering 2.60 crore consumers spread all over Maharashtra. Out of which 60% consumers are in Rural area and 40% consumers in Urban area. It is constant endeavor of MSEDCL to encourage consumers for energy bill payment by providing payment facility in their vicinity. In this process of consumer facilitation MSEDCL introduced the new collection channel "MSEDCL Wallet".

MSEDCL Wallet :

It is MSEDCL's own wallet based collection system to engage small entrepreneurs like Grocery Shop, General Store, Medical Stores and Existing Agencies Services to facilitate consumers to pay their energy bills in their locality itself.



Features of MSEDCL Wallet:

Online registration process with minimum documents.

Good commission/ returns with auto credit in wallet.

No need to visit MSEDCL office

Simple and User friendly Mobile based as well as Computer based system.

Easy Online wallet recharges process.





Who can be a Wallet holder :

- a. Individuals (Age 18 years+)
- b. Grocery shops, Daily needs shop owner, Medical Shops and Saving Group
- c. MSEDCL Bill Distribution and Meter Reading Agencies.



Registration:

Documents required for verification and registration.

- i. Aadhar Card
- ii. Pan Card
- iii. GST Registration Certificate (If Applicable)
- iv. Shop & establishment certificate (Applicable for other than individual)
- v. Address Proof (If address on Aadhar card is different from business place)
- vi. Photo Graph
- vii. Cancelled Cheque

Wallet request will be approved by Head Office MSEDCL. All communications will be done on registered Email ID & Mobile No.



Recharge :

Recharge Limit

- First time minimum wallet recharge Rs. 5,000/-
- Subsequent recharge in multiples of Rs. 1000/-

Recharge payment Option

Online payment - using Debit card, Credit card, Net Banking.



Collection Process :

- After recharge, wallet owner can collect the amount from consumers through MSEDCL wallet.
- Mode of collection from consumer is CASH only.
- SMS will be delivered to consumers from MSEDCL on making payment at MSEDCL wallet as acknowledgement/ receipt of payment. (Wallet owner can also provide the receipt to consumers from Wallet Application. Printer details are available on wallet portal.)

d. SUB WALLET CONCEPT :

The main wallet holder/owner agency can assign its wallet balance to multiple users by creating sub wallets. The transaction and commission related to sub wallet users will be accounted in main wallet only.



Commission

- Commission rate is Rs. 5.00 per receipt (Taxes Extra as applicable).
- Commission will be credited in wallet on monthly basis.
- Online submission of invoice is necessary for crediting the commission. .



Refund of Amount and Wallet Closure

- Wallet owner can take interim refund from amount in wallet through online request.
- Wallet owner can request for closure of wallet through wallet app. Head Office, MSEDCL will process wallet closure request accordingly.
